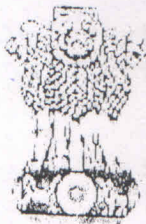

**CIRCULAR**

**Sub: Implementation of Entrepreneurs Development programme (EDP) under PMEGP - reg.**

Entrepreneurs Development programme (EDP) has been made mandatory under PMEGP programme before disbursement of loan to the beneficiaries/candidates and vide Circular No:REGP/PMEGP/CIR.Guide/B&FL/2014-15 dated 19.03.2015 guidelines has also been issued in which it has been indicated that after execution of the MOU with RSETIs/RUDSETIs, EDP programme under PMEGP may be conducted through Departmental Training Centers of KVIC/KVIB, Central and State Government Training Centers and RSETIs/RUDSTIs Centers in the Country.

2. However, in order to speed up the EDP training flow and enhance the disbursement of margin money, conducting regular EDP programme has become essential and thus following modalities are chocked out for better implementation of EDP under PMEGP:

- a. EDP needs to be taken up by the KVIC through utilizing their own infrastructures. Departmental Training Centers needs to be utilized wherever it is available. In case Departmental Training Centers are not available in the State then the infrastructure available with State/Divisional offices in any form like conference hall, committee room or other suitable spaces should be utilized. In such case, expertise of EDP trainers available in other professional organizations such as EDI colleges, EDI of other Ministry and our training associates may be utilized i.e faculty from such above mentioned organization and training associates.



- b. In the event of non-availability of above mentioned infrastructure, Khadi Institutions (KI) infrastructure should be utilized in the above mentioned manner.
- c. Professional organizations i.e. RSETI/RUDSETI may be contacted in case (as mentioned above in para No. a and b) infrastructure are not available.
- d. Expenses towards EDP will be governed as per applicable pattern i.e. Rs.405/- per trainee, per head as per Circular No:REGP/PMEGP/CIR.Guide/B&FL/2014-15 dated 19.03.2015.
- e. Syllabus which is in practice and approved by RUESTIs/RSETIs may be used while conducting EDP under PMEGP as mentioned above.
- f. It may be mentioned that EDP of highest standards as are being provided by RSETI/RUDSTI may be maintained.


