

CIRCULAR

Sub: Simplification in scheme process / procedures – Review of On- Line PMEGRP Form reg.

The Ministry of MSME Govt. of India has launched a new scheme called '**Prime Minister Employment Generation Programme**' (PMEGRP) in the year 2008-09. To empower first generation entrepreneurs for setting up of Micro Enterprises across the country by merging REGP and PMRY scheme. The Ministry has nominated KVIC as a single national level Nodal Agency. The scheme is implementing in rural area through KVIC and KVIB and in urban and rural area through DICs.

2. All PMEGRP implementing agencies i. e. KVIC/KVIB/DIC are hereby informed that the PMEGRP On-Line form available on the KVIC/PMEGRP website has been further simplified by the Ministry. In the present Form, some of unessential items, which may not be necessary at initial stage and can be called at Project submission stage, have been deleted. The provision of Aadhar validation of PMEGRP on-line form can obviate the necessity of photo or father/spouse name in the Form to identify the beneficiary and hence photo and of the details of the applicant is not required.

3. It is also to inform that, Aadhar Validation is available in the recently introduced Udyog Aadhar Memorandum (UAM) for registering MSME units; similar provision has been introduced in the PMEGRP on-line application form.

4. The present form has accordingly been modified to make it more concise (to the point) and user friendly. A copy of the revised Form is enclosed herewith. The revised Form is uploaded on the KVIC/PMEGRP web-side after proper designing.
