Notification

In exercise of the power conferred by Section 30 read with sub-section(3) of Section 21 of the Micro, Small and Medium Enterprises Development Act 2006 (27 of 2006), the Government of Bihar hereby makes the following amendment in Micro and Small Enterprises Facilitation Council Rules, 2007:

1. Name, Effect and Extent :

(i) The rules will be called Micro and Small Enterprises Facilitation Council (Amendment) Rules 2013

(ii) They shall come in to force with immediate effect.

(iii) They shall extend to the whole of Bihar state.

2. A new paragraph bearing no. 5 "A" is substituted after paragraph no. 5 of Micro and Small Enterprises Facilitation Council Rules, 2007 as given below:

5 "A" - Recovery of amount due as arrears of land revenue :- If a buyer does not file any appeal under section 19 of the Act for setting aside any decree, award or other order made either by the council itself or by any institution or centre or prescribed time for filing such appeal has been expired or if such appeal is dismissed, in that situation such decree, award or order shall be executed by the Collector of the District concerned and the amount due shall be recovered as arrears of land revenue.

Order : It is ordered that it should be published in the next extraordinary edition of the Bihar Gazette.
