Entrepreneurship Development programme (EDP) is being carried out under PMEGP and detailed policy guidelines had been issued vide Circular No. PMEGP/Cir.Guide/B&FL/ 2013-14/674 dated 23.09/29.10.2013.

2. It has been noted during various review meetings and in the interaction with various bank officials that RSETI and RUDSETI have been set up for imparting training and have requisite infrastructure and capacity to conduct EDP for PMEGP scheme. A number of RSETI and RUDSETI are already conducting EDP in various States in the Country.

3. It is therefore decided that since adequate number of capable and competent training centres with required infrastructure and manpower are available amongst the departmental training centres of KVIC, KVIB, Govt agencies as well as RSETI and RUDSETIs, the EDP training programme should be allotted only to these agencies and private NGOs may be made ineligible for accreditation for imparting EDP under PMEGP with immediate effect.

4. Directorate of PMEGP will be the nodal Directorate for processing and also for co-coordinating the implementation of the above policy.
