**CIRCULAR**

**Sub:- Indicating Aadhaar Card Number in the applications under PMEGP. - reg.**

With a view to ensure transparency as well as identifying the applicant's status, it has been decided that all the applicants under PMEGP should mention their Aadhaar Card Number in the application with immediate effect.

2. Field Offices may request the applicant, whose applications are pending to be placed before DTFC to indicate Aadhaar Card Number in their application.

3. Suitable mandatory provision (field-column) has been incorporated in the e-tracking system; so as to indicate the Aadhaar Card Number in the e-tracking module.

4. Aadhaar Card Number of the applicants may be called and incorporated in the applications, which were already cleared by the DTFC and yet to be forwarded to banks.

5. In future all the applications under PMEGP and those at categorizing out at Sr. No. 2 & 4 above should indicate the Aadhaar Card Number of the beneficiary and Aadhaar Card linked bank account particulars.

6. All State / Divisional offices of KVIC, KVIB and DIC are requested to take necessary action for compliance of the same with immediate effect.
