


The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").

In the meeting held on dated 22-05-2019 the copy of the claim was provided to Respondent/ Opposite Party and was requested to file their response within fifteen days. The Opposite Party could not provide any response to the council.

As the respondent Buyer is not agreeing to pay the Principal and interest amount for delayed payment, hence, conciliation failed. The council took decision to appoint an arbitrator in this case. Both the parties were directed to suggest the names of two arbitrators, so that a sole arbitrator with the consent of both the parties may be appointed for arbitration.


