




Earlier the instant case was taken up in the meeting dated 2<sup>nd</sup> June, 2017 and as per statement of Opposite Party the Arbitration proceeding was started, hence, the Council felt that the case was dismissed as not maintainable.


The applicant has filed an application to hear their case afresh and adjudicate the same.

The representative of Opposite Party, General Manager/ Engg., N. E. Railway, Gorakhpur submitted the letter before the council. The council gone through the contents of the letter and took decision to send a reply to the Opposite Party, N.E. Railway narrating therein that the council has got full right for conciliation and arbitration on the issue related with MSMEs. The MSMED Act, 2006 has overriding effect. It was decided to direct the Opposite Party to appoint an independent arbitrator with mutual understanding of the applicant and resolve the matter at the earliest. If the respondent fails to appoint an independent arbitrator, then Council will appoint Hon'ble Justice (Retired) as an independent Sole Arbitrator and the cost of arbitration will be borne by both the parties.


