TERMS AND CONDITIONS FOR PARTICIPATION IN THE NATIONAL HANDLOOM EXPO – 2017-18 AT PUNE.

- 1. The nomination for participation shall be sponsored by State Director of Handlooms and Textiles or DCH.
- 2. The Expo shall be organized from 06/01/2018 TO 28/01/2018 at sspms Ground, Pune.
- 3. The actual rent worked out is Rs. 350.00 per sq. ft. The D. C. H. will be giving the organizer a sum of Rs. 45.00 Lac as grants towards infrastructure of the Expo. The benefit of this @ Rs. 100.00 per sq. ft. is passed on to the authorized participants who will only have to pay stall rent of Rs. 250.00 per sq. ft.
- 4. All the primary Handloom Weavers Co-op. Societies/State Handlooms Corporations/APEX Societies and N. G. O. shall be eligible for participation in the Expo. The participation for NGO's shall be subject to the fulfillment of the norms laid down by the CAPART and should be duly recommended by the concerned State Director/Commissioners for Handlooms and Textiles or Office of DCH.
- 5. Allotment of stalls to authorized agencies shall be made by committee constituted for the purpose. Those participants who pay 100% rent in advance will be given priority allotment. Second priority will be given to those who have paid 50% rent. All allotments will be by drawing lots in presence of participants. The decision of the committee shall be final and binding on all.
- 6. No application for cancellation of stalls and refund of stall rent will be considered after the work order for construction is placed with contractor. Also no request will be entertained for exchange of stalls after draw.
- 7. Possession of stalls will only be given on receipt of full payment.
- 8. Last date of receipt of application along with Demand Draft is 6th December, 2017.
- 9. Since the space available is limited. It is requested to kindly send the application at the earliest. Application received after the stipulated date or without payment can be considered subject to availability of space and the number of applications received from the particular state.
- 10. The participants shall be responsible for their products/goods brought for the Expo.
- 11. Only Five handloom producing agencies recommended by concerned State Directors/Commissioner of handlooms will be provided accommodation. However more can be considered subject to availability of space on First Come First Server Basis.

- 12. The participating agency should maintain a record of goods along with its value. Participants are required to pay Local Body Tax as applicable.
- 13. Participants should sell only handloom goods, produced in their state. Participating agencies should furnish undertaking to this effect. Also handloom mark labels should be displayed on all products. India Handloom Brand Label should be displayed if received for product.
- 14. No subletting of stall is permitted. If found suitable action will be initiated.
- 15. All participants are required to insure their goods during Expo 2017-18 at Pune. No compensation will be paid by any Govt. Authority/ Implementing Agency for goods missing or damaged. Participants are fully responsible for their goods.
- 16. Director of Handlooms & Textiles are requested to recommend upto 10 genuine Handloom agencies for participation with the instruction that the participating agencies will only sell genuine handloom products during Expo. Application in the prescribed format duly recommended by the Directorate be sent within time limit.
- 17. No bathroom, toilet facility will be provided on Expo ground as it is not permitted by Local Authority. All participants will have to make their own staying arrangement.
- 18. No cooking in the Expo-premises is permitted.
