

The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").


Applicant was present. Opposite Party was not present.


The case of the Supplier/ Petitioner is that he has filed a complaint under Section 18 of Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before Micro, Small Enterprises Facilitation Council, Bihar, Patna for a direction to ensure payment of Principal amount Rs. 7,85,330/- (Rupees Seven Lakh Eighty Five Thousand Three Hundred Thirty) only for the Goods supplied to M/s Maa Leelawati Enterprises plus interest of Rs. 2,40,350/- totalling Rs. 10,25,680/- (Rupees Ten Lakh Twenty Five Thousand Six hundred Eighty) as per section 16 of the MSMED Act.


The applicant put his claim before the council without any proof of goods supplied to the respondent. The respondent has also given the statement of dues amount to be paid to the applicant. The applicant was not satisfied with the statement of the respondent but he had no any documentary proof to deny the response of the respondent. The council decided to direct the respondent to pay the admitted dues with penal compound interest the 3 times of bank interest with monthly rests notified by the Reserve Bank of India as per the MSMED Act, 2006.
