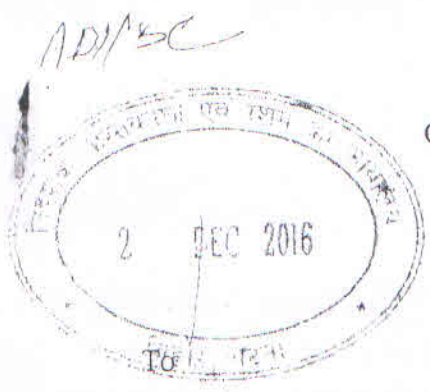

Subject : Directions for release of payments - reg.

Sir/ Madam,

As you are aware that as a part of marketing strategy and publicity measures, this office has been releasing funds to the national level handloom organisations and state implementing agencies for organisation of National & Handloom Expos and other marketing activities under Handloom Marketing Assistance (HMA) a component of National Handloom Development Programme (NHDP). The national level handloom organisations and state implementing agencies further disburse the payments to the agencies for their work who have been engaged in making ground level and other arrangements.

It has now been decided that henceforth -

- 1) All payments will be disbursed to the agencies through Cheque/ Bank Transfer;
- 2) No cash transaction will be made to any agency however, only upto 5% may be disbursed in cash if required for contingency work.
- 3) While furnishing Utilisation Certificate, details of all the payments made through cash, bank transfer / cheque will also be mentioned.

You are therefore, requested to bring it to the knowledge of all implementing agencies engaged in handloom marketing activities to adhere the above instructions strictly failing which no claims will be considered by this office.
