Guidelines for implementation of Concessional Credit Component for Handloom Sector.

In pursuance of guidelines issued on vide OM No. 6/2/99/DCH/16-17/DHDS/NIMRC dated 27/06/2016 regarding development of a centralized online system which will have the facility of crediting the margin money directly in to the loan account of weaver and interest subvention to concerned Bank branch, "Handloom Weaver MUDRA Portal" has been developed in association with Punjab National Bank for online claim and disbursement of margin money, interest subsidy and credit guarantee fee.

2. This portal will become operational for all the participating Banks under Weaver MUDRA Scheme by 01.04.2017.
3. Participating Banks will claim the financial assistance in terms of margin money, interest subvention and credit guarantee fee through this portal w.e.f. 01/04/2017.
4. For becoming participating Bank to use the portal, Banks are required to finalize their product under Weaver MUDRA Scheme and submit to Office of Development Commissioner for Handlooms for approval.
5. After approval from this office as mentioned in para 4 above, Punjab National Bank will be discharging the task of creation, deletion and modification of the Superuser for Head Office of the participating Banks.
