
The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").

The case of the Supplier/ Petitioner is that he has filed a complaint under Section 18 of Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before Micro, Small Enterprises Facilitation Council, Bihar, Patna for a direction to ensure payment of Principal amount Rs. 7,85,330/- (Rupees Seven Lakh Eighty Five Thousand Three Hundred Thirty) only for the Goods supplied to M/s Maa Leelawati Enterprises plus interest of Rs. 2,40,350/- totalling Rs. 10,25,680/- (Rupees Ten Lakh Twenty Five Thousand Six hundred Eighty) as per section 16 of the MSMED Act.


Copy of the complaint was sent vide this Council Letter No. 3174 dated 12th September, 2018. Response dt. 03.10.2018 of the Buyer was received for which rejoinder of the applicant was sought for vide Letter no. 3736 dt. 29.10.2018 and the applicant has submitted his rejoinder dt. 06.11.2018.

The Council felt that Conciliation proceeding failed and stood terminated and the Council took decision to start Arbitration proceeding. The applicant was directed to submit his claim duly certified by CA supported with an affidavit.
