
The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").

In compliance of the direction given by the Council in the last meeting dated 21-02-2019 the Applicant has submitted his claim duly certified by CA and supported with an affidavit.


The Respondent/ Opposite Party raised that the copy of the claim has not been provided to them which may be provided so that they can file their response.

The Council ordered that a copy of the claim be provided to the Respondent/ Opposite Party who will thereafter file their response within fifteen days.


After receipt of the response from the Respondent/ Opposite Party the case will be listed for hearing in subsequent meeting.
