Applicant was present. Later on representative of Opposite Party was also present.


The case of the Supplier/ Petitioner is that they have filed a complaint under Rule 18 of Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before the Council on 16-03-2017 for a direction to ensure payment of P.A. with total interest Rs. 12,37,187/- (Rupees Twelve Lakh Thirty Seven Thousand One hundred Eighty Seven) u/s 16 of the Act for the goods and services provided to M/s SRC Company, Secundarabad.


Both the parties were requested to sit together for conciliation and settle their issues amicably vide the Council letter no. 2769 dated 06.09.2017


Further in the meeting dated 16.08.2017 and 7th September 2017 Principal employer CEO, KBUNL, NTPS, Kanti, Muzaffarpur was requested to look into the matter personally and to resolve the issue. CEO, KBUNL, NTPS, Kanti, Muzaffarpur was again requested to resolve the dispute in the meeting date 10.10.2018. Outcome of the conciliation is awaited, hence it is presumed that Conciliation proceeding failed and stood terminated.

As conciliation has been terminated the Council took decision to start arbitration proceeding. The applicant was directed to submit his claim duly certified by CA supported with an affidavit.
