
The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").


The applicant himself was absent; he was represented through his daughter. Opposite Party was absent. Representative of CEO, KBUNL, NTPS, Kanti, Muzaffarpur was also present.


The case of the Supplier/ Petitioner is that they have filed a complaint under Rule 18 of Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before the Council on 24-01-2017 for a direction to ensure payment of P.A. with total interest Rs. 10,46,875/- (Rupees Ten Lakh Forty Six Thousand Eight hundred Seventy Five) u/s 16 of the Act for the goods and services provided to M/s Techpro Systems Limited, Kasarwadi, Pune.


Further in the meeting dated 16.08.2017 and 7<sup>th</sup> September 2017 Principal employer CEO, KBUNL, NTPC, Kanti, Muzaffarpur was requested to look into the matter personally and to resolve the issue. In the meeting dated 10.10.18 it was brought to the notice of the Council that the O.P. vide his letter dated 29.09.2015 had requested to AGM (Project) KBUNL to release the amount of Rs. 6.25 lakh to the applicant but Principal employer is not making payment. Then CEO, KBUNL was directed to make payment after due verification vide letter no 3881 dated 06.11.2018.






