The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").


In the last meeting dated 21-02-2019 the council decided to direct the Opposite Party to appoint an independent arbitrator with mutual understanding of the applicant and resolve the matter at the earliest.


The Opposite Party vide his letter dated 25-03-2019 forwarded the award dated 15-03-2019 passed by the Sole Arbitrator -cum- Dy. CSTE/ HQ/ NER (Serving Officer of Railway) which is against the applicant.


The Applicant stated that even written protest raised by the Applicant, the Opposite Party, N. E. Railway, Gorakhpur did not change the Sole Arbitrator. Further they stated that the Opposite Party appointed a serving personnel of Railway as arbitrator whereas, a retired personnel ought to be appointed as sole arbitrator. The Applicant has submitted their rejoinder. The Council took decision that the rejoinder of the Applicant be sent to the Opposite Party for their response.


