


The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").



Ltd., Police Line Road, Gaya Sadar, Pin-823001 has filed a complaint under Section 18 of the Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before the Micro and Small Enterprises Facilitation Council, Bihar, Patna for a direction to ensure payment of Principal amount Rs. 15,28,035/- (Rupees Fifteen Lakh Twenty Eight Thousand Thirty Five) only for the Goods supplied to M/s Essel Vidyut Vitaran ( Muzaffarpur) Ltd. Mumbai for his work at Muzaffarpur (Bihar) plus interest of Rs. 14,40,513/- (Rupees Fourteen Lakh Forty Thousand Five Hundred Thirteen) totalling Rs. 29,68,548/- (Rupees Twenty Nine Lakh Sixty Eight Thousand Five Hundred Forty Eight) as per section 16 of the MSMED Act.




