
### Order


The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").



Ltd., 3<sup>rd</sup> Floor, 306, 307 Verma Centre, Boring Road Crossing, Patna-800001 has filed a complaint under Section 18 of the Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before the Micro and Small Enterprises Facilitation Council, Bihar, Patna for a direction to ensure payment of Principal amount Rs. 2,95,313/- (Rupees Two Lakh Ninety Five Thousand Three Hundred Thirteen) only for the Goods supplied to M/s Maa Laxmi Enterprises, Distt- Begusarai plus interest of Rs. 7,81,985/- totalling Rs. 10,77,298/- (Rupees Ten Lakh Seventy Seven Thousand Two Hundred Ninety Eight) as per section 16 of the MSMED Act.


Copy of the complaint was forwarded to the Respondent Buyer by the applicant; however copy of the same was also sent vide this Council Letter No. 4264 dated 03<sup>rd</sup> December, 2018 but no response has been received from the Respondent Buyer.


