

The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council").


M/s Shrawasthi Agrotech Pvt. Ltd., 3rd Floor, 306, 307 Verma Centre, Boring Road Crossing, Patna-800001 has filed a complaint under Section 18 of the Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before the Micro and Small Enterprises Facilitation Council, Bihar, Patna for a direction to ensure payment of Principal amount Rs. 12,01,346/- (Rupees Twelve Lakh One Thousand Three Hundred Forty Six) only for the Goods supplied to M/s Ekta Mahila Kukkut Palak Swawlambi Sahkari Samiti Ltd., Pattabari, Shikaripara, Dumka, Jharkhand plus interest of Rs. 37,96,483/- totalling Rs. 49,97,829/- (Rupees Forty Nine Lakh Ninety Seven Thousand Eight Hundred Twenty Nine) as per section 16 of the MSMED Act

Copy of the complaint was forwarded to the Respondent Buyer by the applicant; however copy of the same was also sent vide this Council Letter No. 4258 dated 03rd December, 2018.

The Opposite Party vide his letter dated 27-12-2018 has not denied the claim of the applicant but demanded copy of Udyog Aadhaar Memorandum and Registration Certificate of Registrar of Company which is not relevant. The Opposite Party should have denied the claim of the applicant or controvert the claim. However, the Council directed the Applicant to file their claim in duplicate within fifteen days before the Council duly certified by the Chartered Accountant and supported by the affidavit. After receipt of the claim the Council Secretariat shall send the copy to the Opposite Party. The Opposite Party was directed to send their response within fifteen days of receipt of the claim.




