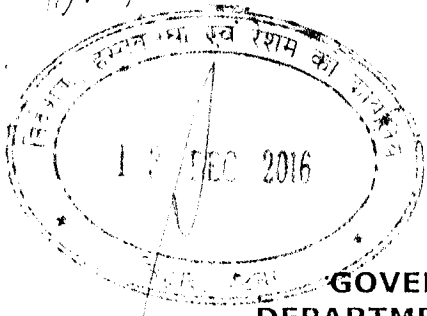

I am happy to inform that the Government of Andhra Pradesh is organizing the National Handloom Expo 2016-17 at **" A PLUS CONVENTION CENTRE", Moghalrajapuram, Vijayawada , Krishan District, A.P.State from 26.12.2016 to 06.01.2017 for (12) days.** The Government of Andhra Pradesh has sanctioned funds for organizing National Handloom expo under State Plan for the year 2016-17. The Implementing Agency is the Director of Handlooms & Textiles A.P., Amaravathi, Guntur Dist, for the said NHE- 2016-17.

All the Primary Handloom Weavers Cooperative Societies/Apex Societies/State Handloom Corporations/N.G.Os./Handloom Clusters/Award Winners are eligible to participate in the National Handloom Expo-2016-17, Vijayawada. The participation of N.G.Os shall be subject to the fulfillment of the norms laid down by the **CAPART** and should be duly recommended by the concerned/State Director/Commissioner for Handlooms and Textiles/Development Commissioner for Handlooms.

It is proposed to take all possible steps to ensure high volume of sales by making adequate publicity and other arrangements to attract the public.

The Stall rent is fixed @ **Rs. 200/-** per Sq. feet payable by the participants and the Electricity Consumption Charges will be extra. The stalls admeasuring 100 Sq. feet, 200 Sq. feet and 500 Sq. feet will be made available. Participants shall have to obtain Demand Draft in favour of **"The Commissioner of Handlooms and Textiles, A.P., Amaravathi, Gutnur"** payable at Vijayawada for the required space. The participants shall carry the original Demand Drafts on hand and no Xerox copies of N.Demand Drafts will be considered.

The participants who pay 100% of amount of rent in advance will be given first priority and participants who pay 50% amount in advance will be given second preference and the rest of the participants will be given third preference for allotment of stalls as far as possible. Allotment of stalls will be made by the Committee constituted for the purpose, subject to availability of space. Possession of the stalls will be given only on receipt of full payment. The decision of the Allotment of Stalls Committee is final in this regard and no arguments will be entertained.


The participants should display and sell only Handloom Mark labeled cloth and the Societies registered under the Handloom Mark Scheme shall only be sponsored. No participant will be allowed to participate in the National Handloom Expo-2016-17 at Vijayawada without the recommendation of the Director/Commissioner of Handlooms of the concerned State.

I request you kindly to circulate the contents of this letter along with Terms & Conditions attached to all Primary Handloom Weavers Cooperative Societies including the Apex Society in your State and recommend not more than four/five eligible Handloom Primary/Apex Societies/Corporations/NGOs/Handloom Clusters to participate in the National Handloom Expo-2016-17 at Vijayawada and see that the application along with Demand Draft shall reach by **20.12.2016** so as to enable us to make necessary arrangements for allotment of stalls etc., by **26.12.2016**.

**TERMS & CONDITIONS FOR PARTICIPATION IN THE NATIONAL HANDLOOM  
EXPO-2016-17 AT A PLUS CONVENTION CENTRE, MOGHALRAJAPURAM,  
VIJAYAWADA, KRISHAN DISTRICT, A.P.STATE.**

**SPONSORED BY GOVT. OF A.P.**

1. The Nomination for participation shall be sponsored by the State Commissioner/Director of Handlooms and Textiles concerned.
2. The National Handloom Expo-2016-17 will be organized from 26.12.2016 to 06.01.2017 (12 days).
3. The participant has to pay @ **Rs.200/- per Sq. feet** and the Electricity Consumption Charges are Extra.
4. All the Primary Handloom Weavers Cooperative Societies/Apex Societies/State Handloom Corporations/NGOs are eligible to participate in the National Handloom Expo-2016-17 at Vijayawada. The participation for N.G.Os. shall be subject to the fulfillment of the norms laid down by the CAPART and should be duly recommended by the concerned/State Commissioner/Director of Handlooms and Textiles or Office of D.C.H., New Delhi.
5. Allotment of stalls to the participants/agencies shall be made by the Committee constituted for the purpose. The participants who pay 100% rent in advance will be given 1<sup>st</sup> priority for allotment and next priority will be given to those who pay 50% advance rent. Last preference will be given to others. The decision of the Committee for stall allotment shall be final and binding on the participants.
6. Separate blocks of stalls will be allotted to the participants from the Home State as far as possible and the stalls in the remaining Blocks only will be allotted to the other participants. Decision of the EXPO Authorities shall be final in this regard and shall be binding on the participants.
7. Possession of Stalls will only be given on receipt of full payment of rent.
8. Last date for Receipt of Applications along with Demand Draft is **20.12.2016.**
9. Applications received after the stipulated date or without payment will be considered subject to availability of space and the number of applications received from the particular State.
10. The participants shall be responsible for the safety of their Products/ Goods brought for the Expo.
11. The participating agency should maintain a record of goods along with its

value and tract of sales, closing stocks etc.,

12. Participants should sell Handloom goods produced in their state and affixed with Handloom Mark only and the participating Agencies should furnish an undertaking to this effect.
13. No sub-letting of stall is permitted. If found, suitable action like block listing of the society will be initiated apart from eviction from Expo duly forfeiting the rent already paid and imposing penalty as decided by the Expo Authorities.
14. If participants are found selling other than handloom products, they will be debarred from participation in the present and future Expos also.
15. Not more than (02) Persons will be allowed to stay at night in the stall. Participating Agency should give two Passport size Photographs of such Persons, so that they will be issued identity cards by Expo Authority.
16. No cooking will be permitted in the Expo-premises.
17. **All Guidelines given by D.C.H. in this regard will have to be complied with.**
18. No compensation will be given by Govt. of A.P./ Govt. of India in case of the Goods lost missing or damaged during Expo/Transit period.
19. The Organizers will take all necessary steps for providing amenities/ facilities like Canteen, Water, Electricity, Ceiling or Pedestal Fans including Insurance against Theft, Earthquake and fire apart from keeping Stand-by Fire Brigade, Medical Assistance, Police Outpost etc.
20. The Organizers will also arrange Cultural Events Daily by the amateur Artists during evening time to attract more and more Public, besides publicity through Electronic and Print Media, Hoardings, Banners, Pamphlets etc., to boost the sales.
21. The participants should display and sell only Handloom Mark labelled cloth and the Societies registered under the Handloom Mark Scheme shall only be allowed.
