

The instant case was taken up by the Micro and Small Enterprises Facilitation Council (hereinafter referred to as "Council")


The applicant himself was absent, he was represented through his daughter. Opposite Party was also present through his Lawyer Sri Krishna Kant Singh.


The case of the Supplier/ Petitioner is that they have filed a complaint under Rule 18 of Micro, Small and Medium Enterprises Development (MSMED) Act, 2006 before the Council on 16-03-2017 for a direction to ensure payment of P.A. with total interest Rs. 12,37,187 (Rupees Twelve Lakh Thirty Seven Thousand One hundred Eighty Seven) u/s 16 of the Act for the goods and services provided to M/s SRC Company, Secunderabad.

Representative of SRC Company placed his representation before the council in which he denied the claim of the applicant and said that no dues is pending with them that should be paid. The council advised the representative of the applicant to produce claim before the council with receipt of service or goods supplied to SRC Company. The applicant was allowed 30 days time for submitting the claim.
