

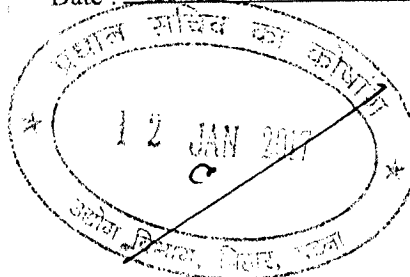

TERMS AND CONDITIONS FOR PARTICIPATION
IN THE NATIONAL HANDLOOM EXPO 2017 AT BHUBANESWAR

1. The nomination for participation shall be recommended by the State Director of Handlooms and Textiles of the concern state. No application will be entertained without recommendation of Director of Handlooms and Textiles of the respective State.
2. All the primary Handloom Weavers Coop. Societies/State Handloom Corporations/Apex Societies and NGO shall be eligible for participation in the Expo. The participation of NGOs shall be subject to fulfillment of the norms laid down by the CAPART and should be duly recommended by the concerned State Director/Commissioner for Handlooms & Textiles or D.C.H.
3. Allotment of stalls & priority will be as under :

The selection of participants and allotment of stalls shall be made by the Committee constituted for the purpose. All allotments will be made by drawing of lots in presence of the participants. The decision of the Committee shall be final & binding on all.

 - a) Participants will have to submit their application for request of stall with full payment of rent by demand draft along with recommendation of the Director, Textiles of their State with Handloom Mark Certificate.
 - b) Preference will be given to Handloom Mark Holder Corporations/Societies.
 - c) Before submitting their application with D.D, the participants should ensure that their name is recommended by the Director of Textiles of their State.
4. The participants shall pay Rs.190/- per Sft. towards stall rent & electricity charges. All participants have to pay their stall rent by Demand Draft only. No RTGS payment will be accepted. Part payment will not be accepted & the application will be rejected.
5. Last date of receipt of application with demand draft is 25/01/17.
6. The participants shall be fully responsible for the security of their products/goods brought for the expo.
7. The participating agency should maintain record of goods with their possession along with its value.

8. Participants should sale only handloom goods produced in their state and they should furnish undertaking to this effect. Also Handloom Mark level should be displayed on all products.
 9. No subletting of stall is permitted. If detected, suitable action shall be taken against the concerned participants.
 10. All participants are required to ensure their goods during the expo period. No compensation will be paid by any Govt. authority/ Implementing Agency for goods missing or damaged or destroyed due to natural calamities. Participants shall be fully responsible for their goods.
 11. Not more than 2, 4, 6, 8 & 10 will be allowed to stay at night in the stall of 250 Sft./500 Sft./ 1000 Sft./1500 Sft./2000 Sft. respectively. Participating agency should give two identity card size photograph of such person so that they will be issued Identity Card by the Expo Authority.
 12. **Cooking is strictly prohibited in the expo premises. The participants have to furnish an undertaking for the purpose. Any deviation will attract criminal action.**
 13. No participants shall be allowed to sale their goods outside the stall.
 14. Participants should cooperate by providing requisite information to Govt. Monitoring Authority.
 15. Participants shall be required to use Jute/Cloth/Paper bags for their customers while conducting retail sale. No Polythene bags that are banned in the city shall be used, failing which penalty shall be imposed.
 16. All local taxes shall be borne by the participants.
 17. Any person of the participating societies creating nuisance/ misbehavior will be liable for criminal action and will be debarred from participating in future events in the State.
 18. Stall allotment date will be announced separately.
 19. All guidelines given by the D.C (H) will have to be complied with by all participants.
