Sub: To establish 120 KLPD grain & molasses base distillery in distt. Vaishali, Bihar.

Sir,

We are one of the biggest distillery in north India, with three running distillery in Haryana & Rajasthan. With the annual turn over of Rs.700.00 crore. we are running our distillery with great social responsibility & Ethical norms, as well as we are listed co. in stock exchange also.

We are very serious to invest & establish 120 KLPD distillery in distt -Vashali, Bihar, for this purpose, we have made land agreement with Mr. Prafull Bhushan Prasad, resident of Bagmaligach Hazipur, distt. Vaishali, as he had already got consent for sale from farmers & land owners, for the 25 acre land, for this consent, we have paid him Rs.-500000.00 (five lacs only) to receive consent from land owners. Further for the supply of plant and machinery, we have paid Rs.15,00000.00 (fifteen lacs only) to M/S PRAJ INDUSTRY, BAVDHAN PUNE.

In response to our application deptt. Of industries (Tech.Dev.) & state investment promotion board (SIPB) has given consent to establish 120 KLPD grain based distillery plant at Andrabar chowk Panapur, Vaishali dated on 9-7-2012, letter no.993, in this connection the excise deptt. has also issued LOI, dated on 26-7-12. Letter no.3602.

Considering the cost factor & alternative use of raw material, we have applied to use the raw material as molasses, in response to this the Industry deptt. Has allowed to use the molasses as alternative raw material dated on 18-09-12 but the excise deptt. has decided to withdraw the LOI dated on 20-9-12 letter no. 4550, which was issued by them dated on 26-7-12, letter no.3602.

We are also presenting affidavit for the 25 acre land purchase. The LOI would be treated cancelled automatically, if the sale of the land will not be registered, it's four month of issuance.

So, it is humble request to issue the LOI & withdraw the cancellation to establish the distillery.
