Sub: Confinement of our Trucks by Sales Tax Department.

Dear Sir,

This is in reference to above, we have already conveyed vide our letter dated 4th June, 2014 towards undue confinement of our Trucks by the Sales Tax officers in the field.

Sir, we may inform you that in spite of our communication and several follow up with your good office we find no action and change in situation as a result of which our trucks are still being seized for no valid reasons. We give below the detail of case that has occurred in last one month.

Once again, we would like to inform that as per understanding with Commercial Tax Department, Bihar (post meeting with Mr. Sudhir Jain, IAS, Ex-Commissioner of Commercial Taxes, Bihar in the years 2012) it was agreed and decided that our vehicle from Ludhiana can proceed to destination directly under Stock transfer but the bill shall be raised from the local office Patna.

The purpose for all this was that Govt., should collect taxes from single sources, which is being collected individually even now company was following the directions secretly and was regular in depositing the tax with the Government which is approximately Rs.9.00 Crore Per year. We could not understand why our trucks are being detained after a period of almost 2 years when we are following the agreed procedure.

We would like to seek an appointment with your good-self to come over and explain the situation.
