Dear Sir, Sub: Supply of Electricity from 33000 kv to Jute Park in Purnia

We wish to draw your kind attention to a suggestion given by you in the Board meeting held on 26th September, 2013. You advised the management of Punrasar Jute Park Limited to make an application for supply of power to Punrasar Jute Park, to North Bihar Power Distribution Co. Ltd, from 33000 kv transmission.

A formal application was made to the appropriate authority on 6th October, 2013. Copies of our application were endorsed to the Principal Secretary, Industries, Govt. of Bihar, to yourself, and the District Magistrate, Purnia. A copy of the application is enclosed for your ready reference.

On regular follow up with the concerned authority, a reply was received on 19th March, 2014 vide their letter no. 474 dated 04.03.2014. A copy of the reply is also enclosed for your ready reference.

We are perplexed as to how the power can be supplied to the Punrasar Jute Park through a dedicated 33000kw line, as proposed in DPR.

Under the circumstances, we would request you to kindly take initiative to resolve the problem at your end so that we can undertake further expansion of Jute Park.

We are pleased to inform you that, in order to consume available surplus power from existing supply from 11000kw line, we are going to expand the production capacity of our existing participating unit from 20mt/day to 35mt/day and a factory shed of approx. 26000square feet shall be constructed soon.
